#### **Gifts of Retirement Assests**

A uniquely effective way to include BMPC in your estate plan is to make a gift of assets held in a qualified retirement plan, such as an IRA, 401(k) or 403(b) account. Since retirement plans are often subject to both income and estate taxes upon the death of the participant (potentially 75% or higher), they present an attractive option for a charitable gift to BMPC which can receive the proceeds completely free of taxes. Alternatively, gifts to BMPC can be made of some or all lifetime distributions from these retirement funds.



To make The BMPC Foundation a beneficiary of a retirement plan, call your financial planner or other advisor to add The Bryn Mawr Presbyterian Church Foundation as a beneficiary.

## Gifts of Life Insurance

Many people own life insurance because of its unique ability to satisfy a variety of needs for financial protection. A further way to make a gift to the Church is by naming The BMPC Foundation as the primary beneficiary or secondary beneficiary of

an existing or new life insurance policy. You can also gift the policy to the church. There may be some added tax benefits to this option.




#### Life Income Gifts

There are many ways to support the work of BMPC through gifts that provide you with income during your lifetime, including:

- Charitable gift annuities
- Deferred charitable gift annuities
- Charitable remainder trusts
- Pooled income funds

Such gifts can provide you with both increased current income as well as significant current income tax deductions. They can also reduce estate taxes. By using assets that may produce little or no income today, such gifts can provide additional income for retirement years. Additionally, these gifts can also eliminate capital gains taxes if the gifts are made with appreciated property such as securities or real estate.

# **Bequests**

The most common estate gift to the Church is a bequest in a will. Bequests allow donors to make gifts that may not have been possible during their lifetimes. They can take several forms:

- **General Bequest:** A gift to BMPC in a stated amount.
- **Specific Bequest:** A gift to BMPC of a specific asset (e.g. stock, artwork, or real estate)
- **Residual Bequest:** A gift to BMPC of all or a percentage of the rest of your estate (the balance remaining after all debts, administrative expenses, taxes, and other bequests have been paid).
- Contingent Bequest: A gift to BMPC as an alternate beneficiary. BMPC would only receive this gift if an individual named in the will is not alive or a named organization is no longer in existence.

The following language can be given to your attorney or financial advisor to make an unrestricted bequest to BMPC in your will:

I hereby give, devise and bequeath to The Bryn Mawr Presbyterian Church Foundation, a nonprofit corporation organized and operating under the laws of the Commonwealth of

Pennsylvania, the sum of
